OWASA's brand will be the focus of our communication strategy and influence service to the community every day.

WATER QUALITY REPORT CARD

Rachel Monschein reported that OWASA met and exceeded the standards under the Federal Safe Drinking Water Act and related State rules for drinking water. OWASA's report includes information about where OWASA water comes from, how it is treated and a summary of our test results. Last year OWASA provided 2.8 billion gallons of drinking water to the Carrboro-Chapel Hill community and tested the drinking water for more than 150 contaminants. The 2010 water quality report card was mailed to our customers this spring and as well as posted on OWASA's website at www.owasa.org.

ITEM SEVEN: UPPER NEUSE CLEAN WATER INITIATIVE PRESENTATION

Bill Holman and Kevin Brice gave a presentation on behalf of the Upper Neuse Clean Water Initiative (UNCWI). The UNCWI protects regional water quality and proposes funding a similar initiative in the Cape Fear River Basin by requesting Raleigh, Durham, Cary, and OWASA to establish a one penny per 100 gallon water rate surcharge to generate revenue for watershed land conservation.

ITEM EIGHT: ORANGE COUNTY MASTER TELECOMMUNICATION PLAN
